#### PROJECT OVERVIEW

- To help GCRTA procure additional funding for ongoing rail car replacement, as well as, assurance that current GRF funding levels are preserved
- To aid in the pursuit of other funding streams (non transportation) in the state budget

#### PROJECT OVERVIEW

- Facilitate meetings between GCRTA and members of the Executive and Legislative Branches to advance GCRTA's legislative agenda
- Coordinate opportunities for legislators and administrative staff to visit GCRTA facilities to better inform state officials on our needs and major issues impacting public transportation



#### PROJECT OVERVIEW

- Two year contract for a two year option for renewal
- Provides continuity of representation during upcoming mid-biennium session, and the next biennium's transportation and general fund cycles
- Support our competitive grant submissions to ODOT, OEPA, and other state departments



- RFP issued March 16, 2020
- Nine (9) interested parties downloaded the package
- Four (4) vendors proposed
