Code Book Updates

Dawn Tarka, Associate Counsel II gave the presentation.

The Board Policies ("Code Book") were codified in 1989 (Resolution 1989-176). They are reviewing and updating them to bring the policies in line with current operations. They are subject to review every 3 years. Today's discussion includes two provisions.

Definitions and Interpretation

- Recommend amending Chapter 212
- In Resolution No. 2015-100, changed title of Code Book from "Policies and Procedures of the Board of Trustees of the Greater Cleveland Regional Transit Authority" to "Codified Rules and Regulations of the Greater Cleveland Regional Transit Authority"
- Update title in Chapter 212

Financial Assistance

- Recommend amending Chapter 465
- · Authorizes applications for federal, state and NOACA-administered grants
- Expand language for NOACA so annual resolution won't be needed
- Update General Manager's title

The purpose of these revisions is to streamline the process. They confirmed with ODOT and NOACA that the language in the Code Book provide sufficient authority for supporting our grant applications without the need to bring a resolution to the Board.
