- III. APPROVAL OF MINUTES
- IV. GENERAL MANAGER'S REPORT: Michael York presenting in Joe Calabrese's absence
 - 1. #'s through November 2012 all are up
 - 2. RTA preparing for the Senior games in July 2013 and the Gay games 2014
 - 3. In the process of obtaining 20 new paratransit vehicles
 - 4. Infrastructure University Cedar underway
 - a. Not safe place to cross after the C.A.B. presented concerns of pedestrian crossing
 - 5. Clifton project construction scheduled to begin June 2013
 - 6. Airport tunnel no significant stalls as of yet
 - 7. ODOT RTA applied for several grants the state has decided that funds will be proportioned through the Congestion Mitigation & Air Quality (CMAQ) program not thru MPO's
 - 8. Fuel cell program –grand opening soon to be announced
 - 9. Xerox to place new screens in Tower City for a pilot period of 7 10days
 - 10. Driver assault issue:
 - a. A new "wall" was piloted, operators are concerned with the night glare on the NABI's; new design to be tested in the next few weeks
 - 11. An RFP is being prepared for new cameras on all but 70 buses with new signage, still working with state legislation
 - 12. New training program 546 operators have been trained expected to have all trained by the end of January 2013
 - 13. CMAQ dollars have been in the millions and paid for trolley fares, funded the health line has helped to purchase buses
 - 14. Brooklyn garage lease has been finalized
 - 15. Airport Red line shuttle only location approved by Hopkins no sign available for riders
 - 16. Healthline bridge plate update still no progress, waiting for the revised prototype
 - a. There will be an opportunity to test the vehicles operator enclosure.
 - b. Convention Center & Medical Mart pick-up/drop off is planned to be on Lakeside Rd. There is a concern about the location verification and confirmation to come
 - c. Reserved signage for wheelchair seating on fixed route buses is being improved
 - d. When surveys are conducted, they should do a better job to be more diverse
 - e. RTA is working with Cuyahoga Community College in industrial training programs
 - 17. Will RTA have to comply with NTHSA quiet vehicle rule? Confirmation and verification to come 1) diesel 2) C&G 3) Hybrid electric cost benefits analysis will be done to determine the most cost effective cannot get FDA funding without complying with rules
 - 18. Jan 28 the website will be reviewed again, C.A.B. members to have the opportunity to review/test before it goes live
 - 19. Pilot program of enhanced turn signals and very bright stop signs have been installed on the back of 50 buses activated when another vehicle begins to pass to help reduce accidents if this works it will be placed on all other coaches and all new buses

VII. ADA COMMITTEE REPORT: Ron Jackson


- 1. NO meeting in January next meeting February 21, 2013
