APPROVAL OF MINUTES

GENERAL MANAGER'S REPORT, Joseph Calabrese General Manager and CEO

- Ridership is down as a result of lower gas prices
- There is a very comprehensive investigation underway regarding the pepper spray incident. A preliminary report should be released on September 15 prior to the Board of Trustees meeting
- There are 20 MV1's paratransit vehicles on order
- Infrastructure:
 - o E. 34th Street the design agreement presented to the Board of Transportation (BOT) on 8/18.
 - o Little Italy Station successfully opened on 8/11
 - Lee Van Aken construction is ongoing
 - o Brookpark construction ongoing tunnel closed on July 20th
 - o E. 116th Station design ongoing .
 - o Gillig CNG Buses CNG station certified and there are new buses on the road
- There have been 11 hiring events held since May 2015 resulting in 341 attendees and 125 people interviewed. There are five more events scheduled through the end of 2015
- RTA Family Health Day is scheduled for September 12th from 11am 4pm at the Harvard Garage for employees only. Health screenings and educational sessions including flu shots
- RTA's annual golf outing for Paralyzed veterans was held August 15th
- The Cleveland Foundation provided a grant to cover the "Art along the Rail" and a reception will be held on September 29th
- Notre Dame to participate in the U-Pass Program subsidizing \$25.00 per month and RTA to match the subsidy
- NOACA annual meeting is scheduled for September 24th
- Upcoming Service updates:
 - o 9/12 & 13 the Blue/Green Lines will be down for the East 81 & East 83 Street bridge work
 - 9/28 10/17 for 19 days the Red Line between Puritas and the Airport will be down for the Brookpark Station construction
 - 10/4 10/17 for 14 days the Waterfront line will be down for grade crossing and track replacement
 - 11/8 11/21 for 14 days the Red Line between Triskett and West Blvd for track work between the "S" curve & W 117th
- The funding for the trolley's will run out in the fall. There are recommendations to cut the costs from \$1.2 million to \$800,000. Those recommendations include:
 - o Discontinue the L Line after September 7th.
 - o Discontinue the 9/12 (Muni lot to Chester Ave)
 - o No change to the "C" Line
 - There have been meetings with local entities to discuss ways to address the funding issues and they have been positive and promising
- Recognition:
 - o RTA has received the Distinguished Budget Presentation Award for the 25th consecutive year.
