## **MINUTES**

The meeting was called to order at 8:30am

Approval of minutes from September and October 2015. There was a motion made by Marty Golob and seconded by David Applefeld, all in favor. Motion was proved unanimously.

General Manager's report, Joseph Calabrese General Manager and CEO

- Infrastructure & service updates:
  - Brookpark going well; there was a brief shutdown for underground work but it is back up
  - The Red Line shutdown has been postponed until Spring 2016
  - o E 34<sup>th</sup> St the design is underway
  - o Lee Van Aken construction is ongoing with scheduled opening in phases
  - o Brookpark construction is ongoing
  - E 116<sup>th</sup> Station the design is ongoing and the St. Luke's Foundation may participate in funding alternatives
  - GILLIG CNG buses the CNG station has been certified. There are 90 busses currently rolling on the streets
  - November 21 & 22 the Blue Line east of Shaker Square for the Lee Van Aken station
    67R buses will replace the trains
  - December 12, 13, 19 & 20 the Red Line will shut down between E 55<sup>th</sup> and Windermere for the E 79<sup>th</sup> bridge and E 120<sup>th</sup> station demolition
  - o Megabus lease has been renewed
  - o DCA dog park lease has been renewed
- Trolley updates:
  - o The funding runs out in the fall
  - o It is recommended to cut costs from \$1.2 million to \$800,000
  - o There is a question on the C Line extension to the Flat's East Bank
  - o There are meetings scheduled with local entities to discuss funding
- Recognitions:
  - o Dr. Flounsay Caver Cleveland State University Levin College of Urban Affairs 2015
  - o Joe Calabrese Governing Magazine's Public Official of the Year
  - RTA has received for the 25<sup>th</sup> consecutive year the Distinguished Budget Presentation Award
- DBE forum on November 15, 2105
  - Sponsored by RTA in collaboration with Cleveland Hopkins Airport, the NEOhio Hispanic Chamber of Commerce and COMTO
  - Created to support the growth and development of women and minority owned businesses with over 25 businesses represented

- o There will be presentations by Rep. Stephanie Howse and Rep. Martin Sweeney
- Budget:
  - o The media has been reaching out with questions
  - There will be additional meetings with the Board of Trustees regarding the increase in fares and the possibility of trimming services
  - o Still hoping for the state and federal government to provide relief
  - Possibility of adding fees to the Personal Care Attendants on disability rides could be eligible for the half fare discounts
  - Looking for hearings prior to any fare increase
  - o The 4% decrease is reflected in the overall revenue
- E-cigarette policy there is a new policy in place that is the same as regular cigarettes it is prohibited to smoke e-cigarettes on GCRTA transportation
- Requested that something be put aside for rail improvements each year
- Hand railings at Brook Park have been replaced
- There have been 14 hiring events since May 2015. 703 have attended, there were 667 applications received, 235 were interviewed resulting in 38 new hires.
- There was a reception held on September 29 along the art on the rail line. The funding came from NOACA and the Cleveland Foundation. There is ongoing fund raising.
- The U-Pass Program
  - Will continue with Notre Dame. The school will subsidize \$25.00 per month and RTA will match.
  - o RTA met with Baldwin Wallace to explore the possibility.
- The USDOT Demonstration Project Grants
  - Two awards for pedestrian safety with up to 80 vehicles and several stations and stops.
- RTA and the Union now have an approved agreement.
- The employee giving campaign will run from October 12 November 20 with a goal of \$150,000 and 50% employee participation. As of November 9, \$73,915 was achieved.
