AUTHORIZING CONTRACT NO. 2017-014 WITH ALSTOM TRANSPORTATION INC. FOR THE FURNISHING OF 200 BREDA LIGHT RAIL VEHICLE 28 INCH STEEL WHEELS, AS SPECIFIED AND AS REQUIRED, IN AN AMOUNT NOT TO EXCEED \$216,252.00 (GENERAL FUND, FLEET MANAGEMENT DEPARTMENT BUDGET)

WHEREAS, the Greater Cleveland Regional Transit Authority has recurring requirements for replacement of 28 inch steel wheels on Breda Light Rail Vehicles (LRV); and

WHEREAS, the bid of ALSTOM Transportation Inc., located at 641 Lexington Ave, 28th Floor New York NY 10022, for the furnishing of 200 Breda LRV 28 inch steel wheels, as specified and as required, in an amount not to exceed \$216,252.00; and

WHEREAS, the CEO, General Manager/Secretary-Treasurer deems the bid of ALSTOM Transportation Inc. to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THERFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of ALSTOM Transportation Inc. for the furnishing of 200 Breda LRV 28 inch steel wheels, as specified and as required, be and the same is hereby accepted.

Section 2. That the CEO, General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with ALSTOM Transportation Inc. for the furnishing of 200 Breda LRV 28 inch steel wheels, as specified and as required.

Section 3. That said contract shall be payable from the General Fund, Fleet Management Department budget, in an amount not to exceed \$216,252.00.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Specifications and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution No. 2015-076; bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that ALSTOM Transportation Inc. will attempt to exceed the 0% minimum DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE/SCOPE: This resolution will allow the Authority to enter into a contract for the furnishing of 200 Breda Light Rail Vehicle (LRV) 28 inch steel wheels, as specified and as required.
- 2.0 DESCRIPTION/JUSTIFICATION: The Authority has an ongoing need to replace the 28 inch LRV resilient wheels due to normal wear that occurs during train service. As part of the LRV's regular maintenance, LRV wheels are measured and machined to return the wheel's profile back into tolerance. When a wheel's diameter falls below 26 inches, it can no longer be machined and must be replaced. The Breda LRV's resilient wheels reduce shock, noise and provide a smoother ride for the Authority's customers.
- 3.0 PROCUREMENT BACKGROUND: The Invitation for Bid (IFB) was posted on the Procurement section of the Authority's web site and advertised in the local newspapers. Twenty-three interested parties downloaded the solicitation package. Three bids were received and opened on March 29, 2017. The bid of ALSTOM Transportation Inc. has been determined by the Procurement Department to be the lowest responsive bid from a responsible bidder.
