AUTHORIZING CONTRACT NO. 2018-017 WITH ASTURI LANDSCAPE GROUP, LLC FOR HEALTHLINE LANDSCAPING SERVICES, AS SPECIFIED, IN AN AMOUNT NOT TO EXCEED \$140,170.01 FOR A THREE-YEAR PERIOD (GENERAL FUND, SERVICE MANAGEMENT DEPARTMENT BUDGET)

WHEREAS, the Authority deems it necessary to acquire a landscape contractor to maintain the landscaping along the HealthLine; and

WHEREAS, the bid of Asturi Landscape Group, LLC located at 30942 Bel Aire Circle, Westlake, OH 44145, was received on March 21, 2018 in an amount not to exceed \$140,170.01 for a period of three years, to perform said services; and

WHEREAS, the CEO, General Manager/Secretary-Treasurer deems the bid of Asturi Landscape Group, LLC to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Asturi Landscape Group, LLC to provide landscaping services along the HealthLine for a period of three years, be and the same is hereby accepted.

Section 2. That the CEO, General Manager/Secretary-Treasurer of the Authority be and he is hereby authorized to enter into a contract with Asturi Landscape Group, LLC to provide landscaping services along the HealthLine for a period of three years.

Section 3. That this procurement shall be payable through the General Fund, Service Management Department budget in an amount not to exceed \$140,170.01 for a period of three years.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon funding in future years, compliance by the contractor to the Specifications and Addenda, thereto, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution 2015-76; bonding and insurance requirements; and all applicable laws relating to the contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that Asturi Landscape Group, LLC will attempt to exceed the 20% minimum DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE/SCOPE: This action will allow the Authority to enter into a contract to provide landscaping services along the HealthLine for a three-year period.
- 2.0 DESCRIPTION/JUSTIFICATION: The Authority does not have the manpower, equipment or expertise to properly maintain the landscaping needs along the HealthLine. A landscaping contractor is needed to maintain the high standards established by all stakeholders. This contract includes weekly maintenance of planters and planter beds, bi-weekly maintenance of curb side stations, monthly maintenance of curbside trees and tree beds of curb stations, special planting of annuals in spring and fall, spring and fall clean-up, mulching of shrub, tree and planter beds, chemical spraying, pruning and winter plant protection at locations identified in Attachment A.
- 3.0 PROCUREMENT BACKGROUND: The Invitation for Bid ("IFB") was posted on the GCRTA Procurement website and advertised in the local newspapers. Sixteen interested parties, including potential subcontractors, downloaded the solicitation package. Two bids were received and opened on March 21, 2018, as follows:

Asturi Landscape Group, LLC	\$140,170.01
The Kennedy Companies, LLC	\$168,600.00

The Basis of Award is the lowest responsive bid from a responsible bidder for the Total Base Bid price. The Total Base Bid price of \$140,170.01 from Asturi Landscape Group, LLC is approximately 10% lower than estimate of \$154,545.00. Asturi Landscape Group, LLC was determined to be a responsible bidder.

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: All Affirmative Action requirements have been met. A DBE participation goal of 20% was established for this procurement. Asturi Landscape Group, LLC. has committed to meeting the DBE goal through the utilization of Top Designer Landscaping (African American male-owned) in the amount of \$28,034.02 or 20%.
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This procurement shall be payable through the General Fund, Service Management Department budget in an amount not to exceed \$140,170.01 for a three-year period.
- 7.0 ALTERNATIVES: Reject this offer. Rejection of this offer will result in a delay in the maintenance of the landscaping along the HealthLine.

- 8.0 RECOMMENDATION: It is recommended that the bid of Asturi Landscape Group, LLC be accepted and the resolution passed authorizing the CEO, General Manager/Secretary-Treasurer to enter into a contract.
