AUTHORIZING CONTRACT NO. 2018-097A WITH FUTURE AGE, INC. DBA PROVIDE A RIDE TO PROVIDE CONTRACTED PARATRANSIT SERVICES FOR A THREE-YEAR PERIOD IN AN AMOUNT NOT TO EXCEED \$17,662,825.56, AND IN AMOUNTS NOT TO EXCEED \$6,446,819.50 AND \$6,663,637.70 FOR EACH RESPECTIVE OPTION YEAR, FOR A TOTAL FIVE-YEAR CONTRACT AMOUNT NOT TO EXCEED \$30,773,282.76 (GENERAL FUND, PARATRANSIT DISTRICT DEPARTMENT BUDGET)

WHEREAS, the Americans with Disabilities Act (ADA) of 1990 requires the Greater Cleveland Regional Transit Authority to provide paratransit service to all individuals who, due to physical or cognitive reasons, are not able to use fixed route bus or train service; and

WHEREAS, the proposal of Future Age, Inc. dba Provide A Ride, located at 4299 Cranwood Parkway, Warrensville Heights, Ohio 44128, to provide contracted paratransit services for a period of three years with two, one-year options, was received on November 1, 2018; and

WHEREAS, after negotiations, an amount not to exceed \$\$17,662,825.56 for the base three-year contract, and amounts not to exceed \$6,446,819.50 and \$6,663,637.70 for each respective option year, for a total contract amount not to exceed \$30,773,282.76, was agreed upon; and

WHEREAS, the Interim CEO, General Manager/Secretary-Treasurer deems the offer of Future Age, Inc. dba Provide A Ride, as negotiated, to provide contracted paratransit services for a period of three years with two, one-year options, to be in the best interest of the Authority and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the proposal submitted by Future Age, Inc. dba Provide A Ride, as negotiated, to provide contracted paratransit services for a period of three-years with two, one-year options, be and the same is hereby accepted.

Section 2. That the Interim CEO, General Manager/Secretary-Treasurer of the Authority be, and he is hereby authorized to enter into a contract with Future Age, Inc. dba Provide A Ride to provide contracted paratransit services for a period of three years with two, one-year options, subject to approval of the exercise of said options by the Interim CEO, General Manager/Secretary-Treasurer.

Section 3. That said contract shall be payable from the General Fund, Paratransit District Department budget in an amount not to exceed \$17,662,825.56 for the base three-year contract, and in amounts not to exceed \$6,446,819.50 and \$6,663,637.70 for each option year, respectively, for a total five-year contract amount not to exceed \$30,773,282.76.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon future funding, compliance by the contractor to the Specifications and Addenda, if any; the Affirmative Action Plan adopted by the Board of Trustees in Resolution No. 2015-76; bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That the Greater Cleveland Regional Transit Authority's Board of Trustees expects that Future Age, Inc. dba Provide A Ride will attempt to exceed the 21.8% minimum DBE goal assigned to this procurement.

Section 6. That this resolution shall become effective immediately upon its adoption.

- 1.0 PURPOSE/SCOPE: This action will allow the Authority to enter into a contract to provide contracted paratransit services for a period of three years, with two, one-year options.
- 2.0 DESCRIPTION/JUSTIFICATION: The Americans with Disabilities Act (ADA) of 1990 requires the Authority to provide complementary Paratransit services to eligible clients who, because of physical or cognitive reasons, are not able to use traditional fixed route bus or train service. Additionally, the Federal Transit Administration (FTA) requires the Authority's Paratransit District to execute every eligible trip request. The Authority has elevated this directive by establishing a "No Denial" policy for eligible trip requests, which fluctuate on a daily basis. All Paratransit services are door-to-door and are provided twenty-four hours per day, seven days per week, and 365 days per year. These requirements make it difficult to effectively schedule all daily trip requests with dedicated Authority Paratransit vehicles and operators. Because the Authority is not able to meet the demand for this service with its own resources, additional transportation providers are necessary. The project manager anticipated that multiple awards may be necessary.

In an effort to provide mandated Paratransit service more cost effectively, an operational decision was made to align all existing purchased transportation contracts to expire simultaneously (May 31, 2019) to attract a larger pool of competitive transportation providers. The new solicitation incorporated Board of Trustees' concerns and was designed to emphasize high quality service at affordable costs.

3.0 PROCUREMENT BACKGROUND: The Request for Proposal ("RFP") was posted on the Procurement web site and advertised in the local newspapers. Nine (9) proposals were received in response to the solicitation on November 1, 2018, and all proposers were interviewed. After evaluation by a panel of Authority employees, in accordance with established Procurement Department policies and procedures, and after negotiations, the proposal of Future Age, Inc. dba Provide A Ride was determined to be one of three proposals most advantageous to the Authority. After negotiation, an amount not to exceed \$17,662,825.56 for the base three-year contract and an amount not to exceed \$6,446,819.50 and \$6,663,637.70 for each respective option year, for a total five-year contract amount not to exceed \$30,773,282.76, was agreed upon. It is anticipated that Future Age, Inc. dba Provide A Ride will provide approximately 60% of the contracted paratransit service required. The balance of the required service will be awarded under separate resolutions.

Future Age, Inc. dba Provide A Ride has been in business for over 30 years, and has 19 years of experience as an Authority Paratransit contractor. Located in Warrensville Heights, Ohio, Future Age, Inc. dba Provide A Ride supports and maintains the local workforce, and will offer increased driver wages to improve quality and retention. They demonstrated a comprehensive vehicle maintenance plan, as well as the commitment to purchase new vehicles. Additionally, they demonstrated an extensive complaint process and a dedicated intention to improve customer service through the use of training and technology. Other Future Age, Inc. dba Provide A Ride clients include CareSource, Lorain County Job and Family Services, and Cuyahoga County Board of Disabilities.

A cost analysis was performed and the Procurement Department has determined the offer of Future Age, Inc. dba Provide A Ride to be fair and reasonable for the Authority.

- 4.0 AFFIRMATIVE ACTION/DBE BACKGROUND: All Affirmative Action requirements have been met. A 21.8% DBE goal was established for this procurement. Future Age, Inc. dba Provide A Ride has committed to achieving the DBE participation goal through the utilization of Emmanuel Ventures (African American-owned) in the amount of \$1,140,458.00, Kings Transportation Service (African American-owned) in the amount of \$1,140,458.00, Inspiring Lives Forever dba ILF Transportation (Female-owned) in the amount of \$1,140,458.00, Ace Taxi, Inc. (Asian-owned) in the amount of \$2,146,744.00, and My City Transportation (African American-owned) in the amount of \$1,140,458.00, for a total of \$6,708,576 or 21.8%.
- 5.0 POLICY IMPACT: Does not apply.
- 6.0 ECONOMIC IMPACT: This procurement will be funded through the General Fund, Paratransit Department budget in an amount not to exceed \$17,662,825.56 for the base three-year contract, and in amounts not to exceed \$6,446,819.50 and \$6,663,637.70 for each respective option year, for a total five-year contract amount not to exceed \$30,773,282.76.
- 7.0 ALTERNATIVES: Reject this offer. Rejection of this offer would limit the Authority's ability to provide federally required paratransit service and cause the Authority to be non-compliant with ADA requirements.
- 8.0 RECOMMENDATION: This procurement was discussed by the Board of Trustees at the February 5, 2019 Operational Planning & Infrastructure Committee meeting. It is recommended that the offer of Future Age, Inc. dba Provide A Ride, as negotiated, be accepted and the resolution passed authorizing the Interim CEO, General Manager/Secretary-Treasurer to enter into a contract.
