Subject: State Contract Purchases -Oracle Software Subscription Services and Oracle SaaS Cloud Implementation Services

At the August 11, 2020, Organizational, Services & Performance Monitoring Committee meeting, staff will present a recommendation for the board to approve the projects to upgrade the Oracle applications. The upgrade project includes two components: 1) Oracle Software Subscription services and 2) Oracle SaaS Cloud implementation services.

The current on premise Oracle solution has reached its end of life and premier support will not be available after December 31, 2021. As a result, an upgrade is required. The Authority must perform an upgrade to retain this needed support and after careful evaluation has chosen to use the Oracle SaaS Cloud solution.

RTA has used Oracle applications since mid-1990. These applications are used to support all of RTA's financial, purchasing and human resource activities. This transition allows RTA to gain a substantial increase and improvement in available features, functionality and technology, which includes the following:

- Automatic updates to ensure the most current software version is available
- Unlimited user access from anywhere and anytime (supports remote workers)
- Additional modules (increases operational efficiencies in various areas such as budgeting, agency performance management and various human resource improvements for recruiting and employee performance management)
- Enhanced security
- Improved disaster recovery
- Improved analytics and reporting capabilities

Without these two projects, RTA will be without key software support for essential functions in the financial, purchasing and human resources areas. Contracts for both of these services are available for purchase under State of Ohio contracts. These two contracts were awarded by the State of Ohio as a result of competitive solicitations.

The Oracle Software Subscription Services project will be awarded to Oracle America, Inc. under State Contract No. MCSA0023. The Oracle SaaS Cloud Implementation Services project will be awarded to Diversified Systems, Inc. under State Contract No. 534371. We will be requesting that the Organizational, Services & Performance Monitoring Committee recommend the award of these two contracts at the August 25, 2020 meeting of the Board of Trustees.

Subject: Casualty Insurance Renewal – September 1, 2020

At the August 11, 2020 meeting of the Audit, Safety, Compliance and Real Estate Committee Judy Lincoln, our Director of Risk Management will present on the current status of renewal negotiations for the Excess Liability and the details on the other policies in our Casualty Insurance Program.

GCRTA's casualty insurance program expires on September 1, 2020. This program includes the Excess Liability insurance program with a \$95 million limit of coverage excess of a \$5 million self-insured retention. The other two casualty policies are the Excess Workers' Compensation and the Public Officials'/Employment Practices Liability (EPL) insurance policy.

We engaged in early discussions in May and June with USI and Price Forbes, our casualty insurance brokers. They presented a summary of the market place and we discussed our renewal strategy and their recommendations.

Extensive insurance applications were completed and provided to both incumbent and competitive markets with thorough information on GCRTA's operations, exposures and loss experience as well as our aggressive safety and security programs.

Our brokers informed us that the excess liability market was hardening across all classes, including transit accounts. They confirmed in June that they were seeing increases on virtually all accounts, particularly in the higher risk/exposure sectors of the market such as transportation and rail accounts as always.

We requested a budgeted amount for approximately a 20% increase on the major program, the Excess Liability which seems to be, by far the most difficult market this year. We were granted a 5% budget increase. Our brokers have indicated that the market has worsened since those estimates were developed. They are actively engaged in negotiating with current and potential underwriters now. They have cautioned that the result could be an increase of 25 - 50% or higher. The Excess Workers' Compensation policy is expected to be renewed at a 5% rate increase. The Public Officials' Liability/EPL market is very hard and we have been told to expect a potential increase as high as 30%.

A final resolution containing our recommendations for all lines of coverage to the full board for approval will be brought to the August 25, 2020 Board Meeting.

At the August 11, 2020 External and Stakeholder Relations & Advocacy Committee and subsequently at the Committee of the Whole meeting, staff will present a recommendation to implement certain findings of the fare equity study along with proposed revisions to update various provisions of the fare code.

Staff proposes implementing the following recommendations from the fare study:

- <u>Reduce the price of two all-day passes (adult all-day pass and senior/disabled all-day pass) to an amount equal to 2 fares</u>. Staff recommends reducing the price of these two passes, as well as reducing the student all-day pass by 25 cents, reducing the price of the paratransit all-day pass by 50 cents and adding a provision for a cash surcharge when an all-day pass is used on Park-n-Ride service. Together, these changes will address the financial penalty that some riders experience as a result of the elimination of transfers in 2003.
- 2. <u>Make the 5-trip fare card more available, and revise it to create a card with fewer trips at the same per-trip price</u>. In order to accomplish this, Staff recommends removing the restriction in the policy that 1-trip and 2-trip fare cards may only be sold in bulk, making the 1-trip and 2-trip fare cards available to individuals in small or large quantities. Together, these changes will make the value of the 5-trip fare card available in smaller denominations, allowing customers to access GCRTA's service with a lower cash outlay.

Additional proposed revisions to the fare code include:

- 1. Increasing the sales agent commissions for 1-trip, 2-trip and 5-trip fare cards and all-day passes to be consistent with the rate for the 7-day pass and including the commissions for 1-trip, 2-trip and 5-trip fare cards and all-day passes in the fare code.
- 2. Revising the provision for the student fare discount program to correspond with GCRTA's 2016 shift to selling student tickets directly to the public instead of only through schools.



- 3. Repealing the provision for fares for travel from Medina County to Cuyahoga County and replacing it with a provision that addresses transfers from transit agencies in Lake, Summit, Stark, Portage and Medina Counties.
- 4. Removing the requirement from the College Pass Incentive Program that the college or university must provide assistance in an amount up to \$25.00 a month per student.
- 5. Moving provision permitting the General Manager, Chief Executive Officer to suspend collection of fares during times of emergency from Chapter 242 to the fare code and adding authority to suspend fares for construction related detours.
- 6. Editing for clarity and accuracy.

840.02 STUDENT FARE DISCOUNT PROGRAM.

(a) (1) Any student in grades kindergarten through twelve residing within the County and attending a private or public school certified by the Ohio Department of Education will be entitled to <u>purchase or receiveutilize</u> student tickets at a cost as set forth in Section 840.03, good for a full fare on all Authority services.

- (2) Student tickets shall be available to any school system certified by the Department that elects to sell and/or distribute such tickets to its student population.
- (32) Any rider using a student ticket is responsible for maintaining in his or her possession proof of enrollment in a school and/or system certified by the <u>Ohio</u> Department<u>of Education</u> and must produce such evidence if so requested by any Authority personnel.
- (4) Any student who wishes to utilize Authority service without a student ticket must pay the full applicable rate of fare.

(b) The General Manager/Secretary-Treasurer, Chief Executive Officer is hereby directed to notify all schools and systems within the County that are certified by the Department of the Authority's revised student fare discount program and to complete may execute agreements for the sale and/or distribution of new-student tickets and passes.

 - (2) The violation fare shall be paid within thirty days of the mailing of the notice of fare violation by U.S. mail, GCRTA website, or in person at the GCRTA Customer Service Center.
