GCRTA Carries an All-Risk Property Insurance Policy; covered perils include Fire, Wind, Flood and collapse, to name a few.

- Replacement Cost Coverage
- Protects Real and Personal Property for which GCRTA is responsible
- Bus Garages, Rail Complex, Rail Stations, Rail and Bus fleet (non-collision only)

#### Current Carrier – FM Global

- Blanket Limit: \$500 million, Deductible \$250,000
- Total Insured Value \$1.77 billion
- FM Global is one of the premier property insurers in the world and GCRTA has had coverage with them for many years.
- However, this year they announced in August that they would nonrenew GCRTA as an account due to the Rail / Rolling Stock exposure which is not considered part of their core business.



- Given the decision by FM Global and the continued hardening market and expected significant rate increases, we are working with Aon, our property insurance broker, to conduct a competitive marketing effort.
- An underwriting submission was compiled and sent out to many different property insurance markets in the US, Bermuda and London



- Expiring premium for 1-1-20/21 policy period \$825,930.
- 2021 Budgeted amount: \$1,280,200 or a 55% increase based on guidance from our insurance brokers.
- Given the combination of no incumbent carrier, the very difficult property insurance market, and some recent loss experience in our record, this is not an unreasonable forecast.

- Evaluation and recommendations to be completed by 12-9-20.
