

Main Features – Connecting Our Community

What we learned from the public in 2019:

- Prioritize trips to work, education, and health care
- Provide more frequent service all day
- Provide more direct transportation, less need to transfer between transit vehicles on trips between city and suburbs








Current Route Page






Summary

- NEXT GEN RTA reflects community priorities, including frequent service (every 15 minutes or better) all day
- The number of *jobs* within ½ mile of frequent service will increase by 50,000 jobs or 25%
- The number of *residents* within ½ mile of frequent service will increase by 167,000 residents or 100%
- The service emphasizes key corridors in the Strategic Plan
- Implementation is targeted for June 2021

As discussed at the December 1, 2020 Committee meeting, GCRTA's All-Risk Property Insurance Policy expires on January 1, 2021.

- Covers all Real and Personal Property for which GCRTA is responsible
- Bus Garages, Rail Complex, Rail Stations, Rail and Bus fleet (non-collision only)

RTA

- Incumbent Carrier is FM Global
 - Blanket Limit: \$500 million, Deductible \$250,000
 - Total Insured Value \$1.77 billion
 - FM Global informed us this year that they would non-renew GCRTA as an account due to the Rail / Rolling Stock exposure which is not considered part of their core business.
 - As described at the Committee Presentation on 12-1-2020, we worked with Aon, our property insurance broker, to conduct a competitive marketing effort.

RTA

- The results of the marketing effort are that the best proposals were from two different insurance markets; one for the traditional property insurance coverage, and one for the Rolling Stock coverage.
- Rolling Stock (both rail and bus) is a unique exposure and only certain insurance markets will consider insuring it.
- Therefore, our recommendation includes placing two separate programs for GCRTA's property insurance coverage as of January 1, 2021.



- The first program will be written by Liberty Mutual and is for the coverage of all GCRTA real and personal property excluding rolling stock.
- The second program is a stand-alone Rolling Stock policy written by Evanston Insurance Company and specifically provides coverage for GCRTA Rolling Stock (both rail and bus).



- Expiring premium for 1-1-20/21 policy period \$825,930.
- 2021 Budgeted amount: \$1,280,200 or a 55% increase based on guidance from our insurance brokers.
- The combined premium for the new combined program is \$1,126,116, an increase of 36% over the expiring premium of \$825,930 and 12% under budget.



- Both Liberty Mutual and Evanston Insurance Company carry the highest possible financial security rating from Best's Insurance Rating service (A XV), demonstrating their financial stability and ability to pay claims.
- More detail on the new program is included with our recommendation in the resolution submitted to you for approval in the board package for today's meeting.
- We are seeking approval to execute this insurance program renewal as recommended.





Public Transit Virtual Rally for Funding

- Last week RTA joined several leading public transportation agencies for a virtual rally to call for significant and immediate emergency federal relief and detail the dire consequences if Congress fails to pass a coronavirus relief package.
- Participants: Indianapolis (Indy Go), Pennsylvania (SEPTA),
 San Francisco (BART), New York (MTA), Denver (RTD) and
 New Orleans.

Virtual Funding Rally RTA Talking Points

RTA received \$112 Million in CARES Act Funding:

- No Layoffs, maintained service, cleaned and disinfected vehicles, and distributed PPE to staff and customers.
- Funding Needs Still Exist \$500 Million in unfunded infrastructure/state of good repair projects.
- Requested Congress/Administration to pass COVID-19
 Relief bill before end of current session.

RTA

Healthy Worksite Silver Award

- RTA has been awarded the Healthy Worksite Silver Level Award for the 2nd consecutive year from the Healthy Business Council of Ohio.
- This award recognizes Ohio employers who demonstrate a commitment to employee wellness through comprehensive worksite health promotion and wellness programs.
- RTA's response to the Pandemic section of the application showed our commitment to adjust programs and to continue to offer support to wellness.





RTA Awarded Ohio Air Quality Grant

- RTA was awarded \$2 million to replace six diesel-powered transit buses with six new compressed natural gas (CNG) powered transit buses.
- The grant will cover 63.7% of the cost to replace the vehicles.
- Presentation to the Board: February 16, 2021
- Estimate delivery date: 10 months after Notice to Proceed






Employee Giving Campaign
