- Increased standard for customer experience expectations



2023-26 Contract – Purchased Transportation

- Balanced People Strategy with business performance metrics
- Increased liability requirements to 3rd party recommendations
- Standardized market fuel escalator/de-escalator
- Standardized billing methods for all vendors
- Utilized 88.64% of base contract in 25 of 36 months



Paratransit Service

- RTA must provide all paratransit trips requested
- Is not permitted to have capacity constraints
- The unfunded federal mandate must be met




Paratransit Service Mandate


- 49 CFR (§ 37.121(a))..each public entity operating a fixed route system shall provide paratransit ... comparable* to the level of service provided to individuals without disabilities who use the fixed route system.
- *Comparability is defined and measured by (§ 37.131):
 - Hours and days of service
 - Service area
 - Response time (trip reservations)
 - Fares
 - Operating without regard to trip purpose
 - Absence of capacity constraints (includes denials)


Flat ridership year - 95% of Pre-covid levels

Greater Cleveland Regional Transit Authority

- In 2023 the original contracts were authorized for a period of three years with two one-year options for renewal under Resolutions:
 - 2023-8 with Future Age, Inc. dba Provide A Ride for a base term NTE \$17,044,485.35
 - 2023-9 with GC Logistics of Mississippi, LLC for a base term NTE \$11,106,075.91
 - 2023-10 with Senior Transportation Connection for a base term NTE \$5,400,370.89
- Notices to Proceed were effective June 1, 2023
- Each contract has \$500,000 in GM/CEO change order signing authority
- Zero change orders have been issued to date

All three contractors remain committed to achieving the 14% DBE participation goal that was assigned to these contracts

Greater Cleveland Regional Transit Authority Community

- Paratransit and Procurement Departments followed the Change Order Process
- These changes have been reviewed and approved by the Change Order Committee
- Amounts requested are consistent with other expenditures related to paratransit service

Recommendation:

Staff requests that the Organizational, Services & Performance Monitoring Committee recommend approval of these proposed change orders and reinstate the General Manager's change order signing authority to \$500,000 for each contract:

- Contract No. 2022-082A with Future Age Inc. dba Provide A Ride in an amount NTE \$6,772,206.71 for a new base contract amount not to exceed \$23,816,692.06
- Contract No. 2022-082B with GC Logistics of Mississippi, LLC in an amount not to exceed \$4,397,910.56 for a new base contract amount not to exceed \$15,503,986.47
- Contract No. 2022-082C with Senior Transportation Connection in an amount not to exceed \$1,060,425.48 for a new base contract amount not to exceed \$6,460,796.37
