## Objects, Targets, & Programs

- Established for all five significant aspects
- o Baseline data obtained in 2014
- Training and communication programs were developed and began in November 2014
- o Completion by December 31, 2015



#### 2015 1st QTR Results

- AGM Batteries installed in 70 buses with goal of 187 at end of 2015
- o AGM Battery life 381,000 vs 133,000 goal
- Lead Acid Battery life 98,000 vs 70,000 goal
- Used Rags use 1350 lbs vs goal of 9100
- Scrap Metal recycling 29,000 lbs vs 185,000 goal



#### 2015 1st QTR Results

- Obtaining and validating baseline data for landfill waste with vendor
- Training has completed 75% of CBMF training and 100% of new hire awareness training
- Weekly spot checks at 100% vs 100% goal
- o Equipment calibration at 100% complete



### Activities Since Last Update

- February 23, 2015 Virginia Tech Audit Scored
   99 out of 100 with only two findings. Both
   have been addressed
- 34 CAR's/PAR's have been issued for all audits to date with 24 closed and 10 open
- Independent ISO 14001 Registrar and Audit firm conducted initial audit on April 8-9, 2015 and determined we are ready for Stage 1 audit



#### Decisions Since Last Update

- EMT sign-off and approval of update to 1
   ESMS procedure issued on April 13, 2015 in response to the Gap Audit findings
- Core teams for Triskett and Hayden have been identified
- Next QMM will include ESMS General
   Awareness training for all GCRTA managers

- Address remaining 10 open CAR's/PAR's
- Independent ISO 14001 Registrar Stage 1
   Audit May 19-21, 2015
- Independent ISO 14001 Registrar Stage 2
   Audit July 13-15, 2015
- Begin Hayden and Triskett core team training and ESMS implementation – Summer 2015
