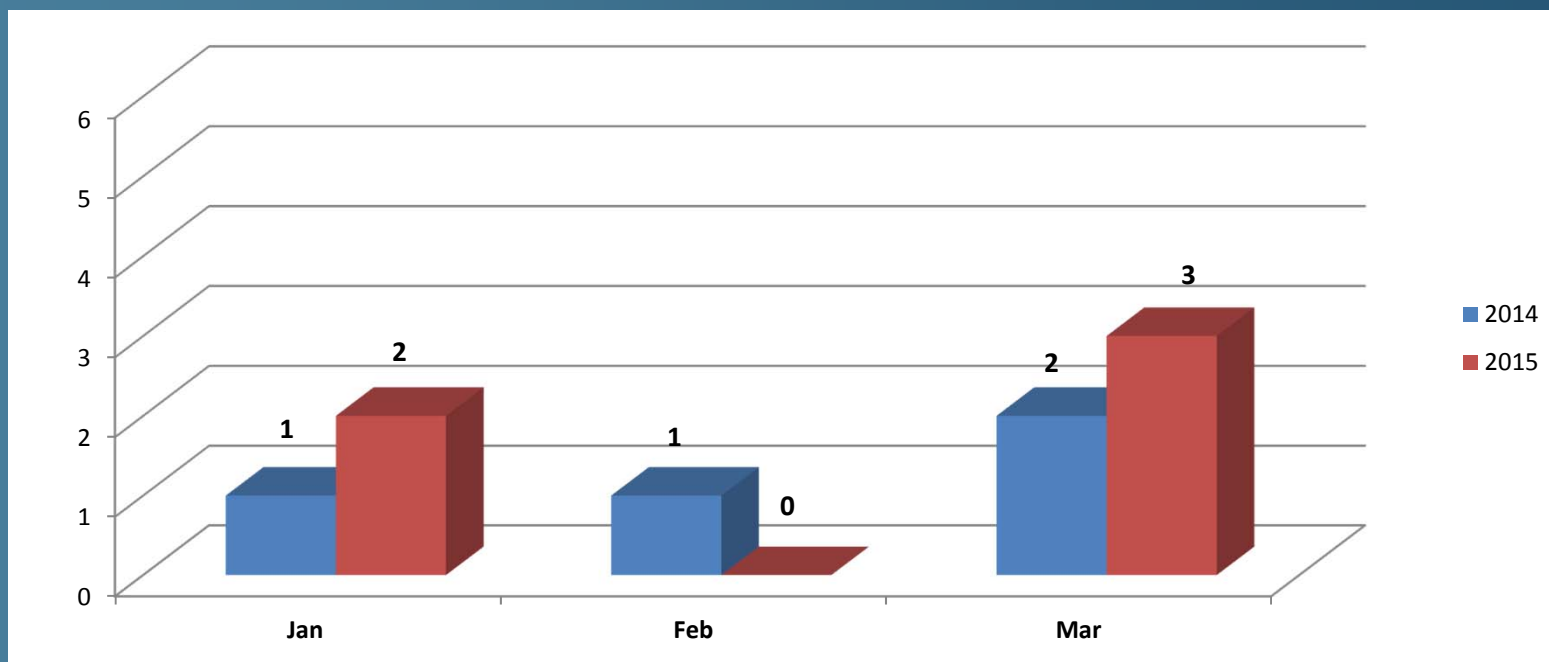

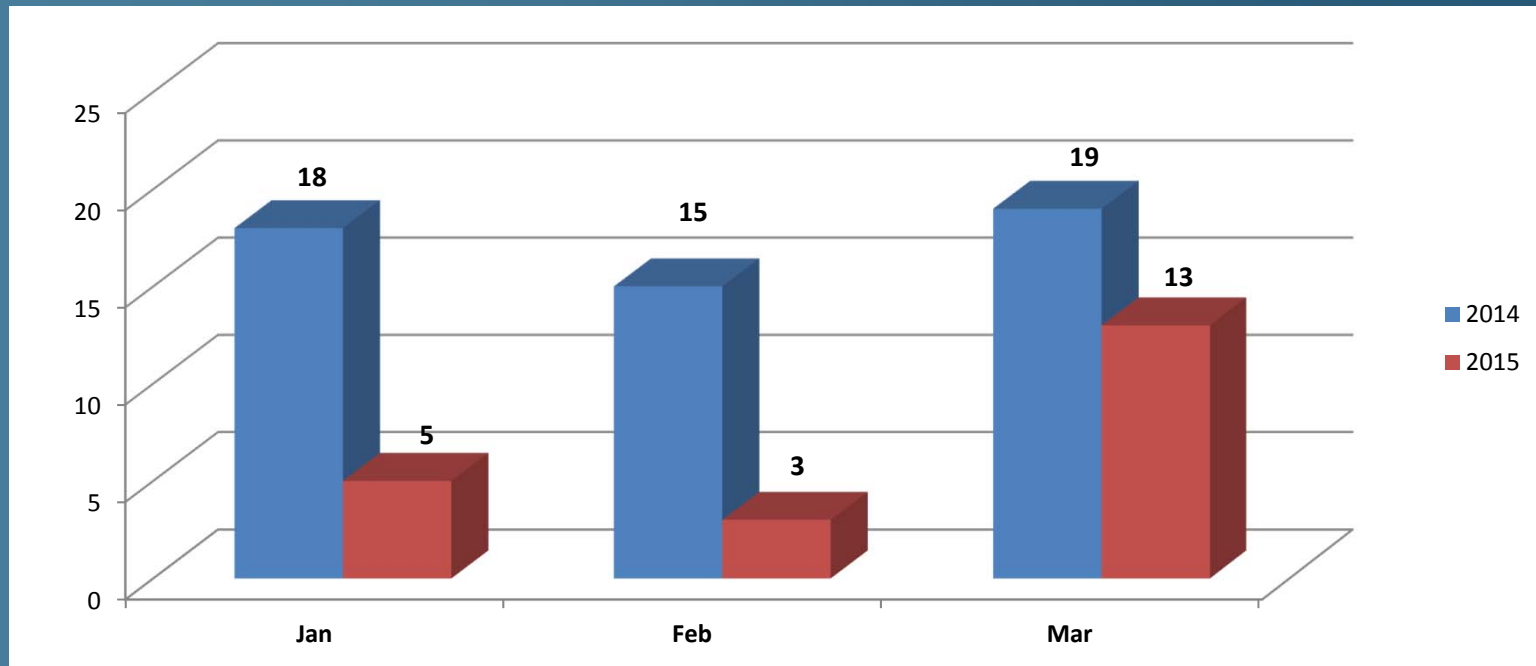


# Operator Assaults – 1<sup>st</sup> Quarter

2015: 5 assaults

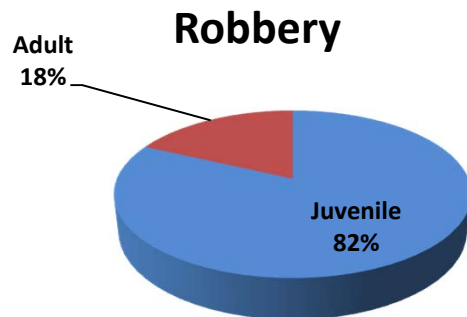
# Thefts & Robberies of Electronic Devices

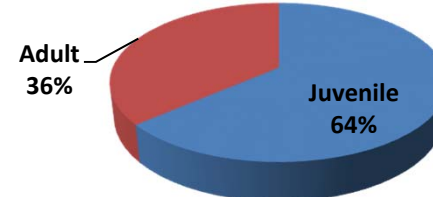

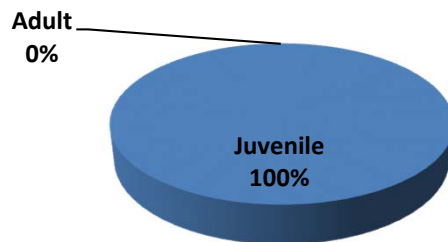

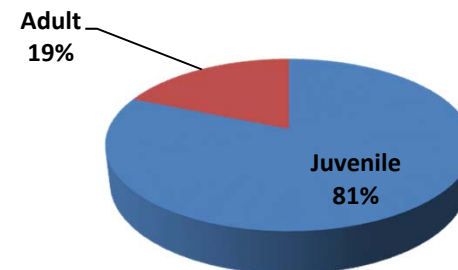

- 6 Current special attentions
- 27 Open complaints under investigation
  - ✓ Letters were sent to all operators who were not personally advised of the outcome of complaint.
