# SUMMARY OF PROPOSED AWARD Printing Press

#### Purpose:

- The purpose of this project is to provide our Print Shop with a working, reliable, and efficient offset press machine to meet the Authority's needs.
- The RTA Print Shop is responsible for the printing and distribution of all RTA timetables and other printed materials.
- Timetables are distributed two weeks prior to a Service Change. Without a functioning printing press it is necessary to outsource them. Outsourcing is more expensive and creates a challenge for scheduling and delivery of timetables to meet Service Change demands.

#### **Current Status:**

- The existing press is a 1997 ManRoland 305P 5-Color printing press. The machine is currently non-operational. A third party press repair company inspected the press and provided an estimate of repairs (parts and labor). That estimate was \$311,000.
- On the average, we spend \$30,000 per service change (or \$120,000 per year) to outsource timetables and other printed materials that we should be able to process in-house.
- The project manager prepared a cost benefit analysis and determined that purchasing a new printing press was in the best interest of the Authority.
- The useful life of a new printing press is 15 20 years.



#### **Benefits:**

- The new 4-color press machine will allow the Print Shop to produce the newly designed two/three color timetables and other printed materials in-house.
- The new machine can use up to 50% less electricity and provide the Authority with reliable equipment.
- The new machine will not require additional infrastructure or major electrical work.
- With this purchase we expect to eliminate all outsourcing costs associated with timetable printing.



#### Scope of Services include:

- If approved, the estimated delivery date is Spring/Summer 2019
- Installation & Training:
  - After the new press is installed the Print Shop employees will receive extensive operator training.
