GENERAL MANAGER'S REPORT, Joseph Calabrese, General Manager and CEO

- Ridership: November
 - Average daily up 1.5%
 - YTD down 0.59%
- Sales Tax: December
 - o Up 9.8% from 2013
 - o Up 7.3 from budget
- 2014 Final
 - o Up 3.95% better than 2013 actual
 - Up 1.5% better than the 2014 budget
- There have been complaints of sign pollution on Clifton Blvd these are mandated signs by ODOT however RTA is looking into these complaints
- The Clifton (Cleveland State Line #55) Ribbon cutting took place on December 8. A huge thank you to Mayor Clough and Marisol Simone. Many CAB members attended.
- Work continues and progresses at the Little Italy and Lee/Van Aken stations.
- There is a presentation coming (date to be announced) to the Board of Trustees regarding the E 79th Street station, Board committee meeting of January 6 was canceled due to scheduling conflicts. There is continued work with the city and community to determine how to increase future density around the station.
- State grant awarded to replace four of eight trolleys with new trolleys that look similar to existing. The size will be changing, from 30 feet to 35 feet.
- Student advisory council first meeting the end of this month. The Council will be comprised of major colleges, high school and elementary students – 22 % of RTA riders are students. The plan is to meet three times per year. The objective is to determine what can RTA do to help promote ridership and keep the current riders happy, and encourage better behavior
- RTA has requested assistance from the ADA Committee to look at the existing paratransit application to make revisions to the application including qualifications, fares and benefits to PCA's.
- There was all night rail service on New Years' Eve. Although this was the second year offered ridership was light and it may be considered again next year.
- Joe will continue to mail out info regarding advocacy efforts
- Suggestion for CAB to create an Advocacy Committee to focus on a recent ODOT study with the question of what will be included in the budget to address identified needs and

recommendations. RTA wants a letter signed by riders and mailed to the Governor and the head of ODOT.

- Mayor Clough has been reelected to the Board to serve a term to expire on March 2018
- Continued discussions with Greyhound and Amtrak regarding an intermodal center with RTA connectivity
- Jan 20 the Board commission will be in for further discussions regarding Public Square. Public Square is scheduled to close around February 2. Routing and stops are currently being finalized. Handouts and presentations are being created.
- Lee Shaker station discussions still scheduled, to take place prior to the Jan 20 meeting.
- On February 3 there will be discussions to rebuild the Brookpark station. The design was completed about three years ago. Bids are due this month since funding is needed for the project.
- According to Joe, the bad weather is not causing many delays "things are going pretty well".
- Ronny Anderson has joined leadership with the ATU

- Powerpoint presentation to show RTA's Public Square plan as of January 6, 2015; hope to have this plan confirmed by January 20, 2015
- "While" Public Square is being transformed to a park
- During construction it will be a challenge
- An "enormous" communication system will be on site at "closed" stops
