- More discussion at next Tuesday's meeting regarding the E 34th St station and looking for ways to make the E79th St station (RED line - obligated by law to keep it an accessible station) successful and strong attempts to keep from closing it. The city will tear down the E79th St bridge this year, for the next couple of year this area will be under construction.
- Student Advisory Council: first meeting was held in January with an eager group of students to give them a better understanding of RTA and their advocacy efforts. Next meeting is scheduled for April.
- Public Square: still no firm date. There may be a ground breaking on the 20th and on the 24th routes will change. One change in he plans W Roadway Healthline station will be closed. A new map has been created. Signage has been erected around the square. Joe has met with the media who is eager to assist with getting the word out. RTA employees will be on hand at Tower City to spread the word and answer questions.
- Service shut down on the Tower City Rail on April 18 & 19
- There is an issue with too much signage on Clifton. A few signs may be removed RTA is waiting for an approval from ODOT
- National Transportation day is April 9, 2015. Riders are encouraged to stand up for public transportation.
- Thanks to the ADAC for assisting with the new application form that is currently being used. Other recommendations to the Board to come.
- Water main break in Mayfield a few weeks ago caused damage to the E 120th St substation
- GCRTA crosses the Medina County line and Medina County pays RTA a stipend to go into that county
