GENERAL MANAGER'S REPORT, Michael York, Deputy General Manager of Operations

- The pepper spray incident near Cleveland State University is still under investigation, a preliminary report will be released soon.
- The fleet is changing
  - 20 MV1 vehicles will be purchased for paratransit this vehicle supports at least one wheelchair and is much more economical
  - $\circ$   $\;$  New CNG buses have hit the streets with a new cleaner image.
  - With school starting soon there will be 20 routes where service changes will take
- Upcoming construction causing shut downs:
  - East 81<sup>st</sup> and East 83<sup>rd</sup> St bridges the Blue/Green Lines will be down : August 8 & 9, August 22 & 23, August 29 & 30 and September 12 & 13
  - Brookpark station will be on a 19 day shut down for construction
  - Waterfront line will be down for 14 days
  - $\circ$  Red Line Triskett West Blvd Nov 8 21 will be shut down for construction.
- Public Square: construction well under way there will be issues and delays due to the construction.
- Convention: the RNC has hired an outside firm to work with the transportation of its staff. RTA is applying for security grants, if approved these improvements/enhancements will remain after the RNC is over.
- RTA Police: Chief Joyce believes in community policing. Looking at body camera's to bring another level of accountability to the force.
