GCRTA VACCINATION INCENTIVE PROGRAM

In our efforts to work towards community immunity in the fight against COVID-19, we are now offering fully vaccinated employees a monetary incentive. Vaccinations are available from our Mobile Vaccine Bus (scheduled to be at all GCRTA work locations), pharmacies, medial facilities and many other locations across the county.

* Valid proof of vaccination can be a copy of a vaccination card or another valid proof of vaccination from a healthcare provider, pharmacy, or public health agency (ie. MyChart). Proof must show either the Johnson & Johnson one shot or both doses of the Moderna or Pfizer vaccine.

Directions For Submitting Proof of Full Vaccination



Employees must provide a copy of a valid COVID-19 Vaccination Record Card or other valid proof of vaccination form from a healthcare provider, pharmacy or public health agency. This proof of vaccination form must include your name, the vaccine's name/manufacturer and date(s) of the vaccine dose(s). Vaccination documentation will be maintained in a secured file in Occupational Health and treated as a confidential medical record. Please keep your original card.

We are continuing to provide several methods for you to provide this information:

- Microsoft Outlook Secure Email: To send a secure email; You must put the word [secure] in the message subject line along with your first and last name.
 - For example, Subject Line: [secure] Jane doe
 - Draft a message to occupationalhealth@gcrtta.org
 - Attach a photo or scanned copy of both sides of your COVID-19 vaccination.
 - Send the secure email message.
- Occupational Health Office Fax: (216) 350-5289
- District locations: Drop off a copy of your proof of vaccination card in a sealed envelope at Lock Boxes located near the Dispatcher Window.
- Main Office Building: Drop off a copy of your proof of vaccination card in a sealed envelope to the Occupational Health Office Lock Box on the 2nd Floor.

Upon receiving your vaccination employees should immediately follow one of the above options to submit a copy of your vaccination documentation as soon as possible. All submitted documentation is subject to verification.

Procedure Modification

Government and public health guidance and restrictions regarding COVID-19 and COVID-19 vaccines are changing as new information and research become available. GCRTA reserves the right to modify this program at any time in its sole discretion to adapt to changing guidance and business needs, consistent with its commitment to maintaining a safe and healthy workplace for all its employees. Employees will receive notice and opportunity to comply with changes to this procedure.

Lost Your Vaccination Card?

If you have lost or misplaced your vaccination card, you can contact your vaccination provider or local government office. Many health providers have portals you can access, such as MyChart or FollowMyHealth, where you can download a copy of your vaccination documentation. If not, you can also contact the State Health Department's Immunization Department.
