

RESOLUTION NO. 1996- 51

AUTHORIZING A CONTRACT WITH OHIO DIVERSIFIED SERVICES, INC. FOR PROJECT 6.38 - WATERFRONT TRANSIT LINE - ENTRANCE FROM TOWER CITY STATION FOR AN AMOUNT OF \$97,000.00 (CAPITAL IMPROVEMENT FUND - 100% LOCAL FUNDS) AND STATION ADA IMPROVEMENT PROJECT FOR \$44,457.00 (\$35,566.00 IN FEDERAL FUNDS WHICH REPRESENTS 80% OF THE COST) FOR A TOTAL AMOUNT OF \$141,457.00

WHEREAS, the bid of Ohio Diversified Services, Inc. located at 20226 Detroit Road, Cleveland, Ohio 44116 for installation of the Waterfront Transit Line - Project 6.38 was received on April 2, 1996 for the price set forth in said bid, involving an expenditure of one hundred forty-one thousand four hundred fifty-seven & 00/100 dollars (\$141,457.00); and

WHEREAS, the General Manager deems the bid of Ohio Diversified Services, Inc. to be the lowest responsive bid from a responsible bidder and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of Ohio Diversified Services, Inc. for installation of the Waterfront Transit Line - Entrance From Tower City Station, Project 6.38 be and the same is hereby accepted as the lowest responsive bid from a responsible bidder.

Section 2. That the General Manager be and he is hereby authorized to enter into a contract with Ohio Diversified Services, Inc. for installation of the Waterfront Transit Line - Entrance From Tower City Station, and Station ADA improvements, Project 6.38.

Section 3. That said contract shall be payable from GCRTA Capital Improvement Fund for the Waterfront Transit Line Entrance From Tower City Station - (\$97,000.00) and from Grant OH-03-0136 (\$44,457.00) for station ADA improvements for a total expenditure of (\$141,457.00).

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon compliance by the contractor to the Bid Specifications and Addenda, if any, the Affirmative Action Plan adopted by the Board of Trustees in Resolution 1993-88; bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That this Resolution take effect immediately upon its adoption.
