

RESOLUTION NO. 1997-145

AUTHORIZING CONTRACT #97094 WITH VARIOUS INDIVIDUALS AND COMPANIES FOR THE SALE OF OBSOLETE/SCRAP INVENTORY, AS LISTED, IN AN "AS IS" CONDITION FOR A TOTAL PURCHASE PRICE OF ONE THOUSAND ONE HUNDRED SEVENTY & 76/100 DOLLARS (\$1,170.76).

WHEREAS, the inventory listed in the Attachment hereto has been determined to be obsolete and/or scrap; and

WHEREAS, the bids of various individuals and companies as listed in said Attachment for said obsolete/scrap inventory were received on the 21st day of July, 1997, and

WHEREAS, the General Manager deems the bids of herein named individuals and companies to be the highest responsive bids from responsible bidders and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the bid of the Ohio Museum of Transportation, located at P.O.Box 771230, Cleveland, Ohio 44107-0051 for the purchase of thirty-eight (38) skids (#1, 2, 4, 5, 11, 14, 16, 17, 32, 35, 36, 37, 38, 39, 40, 44, 45, 55, 56, 60, 63, 65, 67, 68, 71, 73, 74, 77, 80, 82, 83, 86, 90, 93, 908, 923, 927, and 929) of obsolete/scrap inventory as listed on the Attachment hereto for a total purchase price of nine hundred ninety-five & 00/100 dollars (\$995.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 2. That the bid of Michael R. Frampton whose address is P. O. Box 38097, Olmsted Falls, Ohio 44138 for the purchase of one (1) skid (#965) of obsolete/scrap inventory as listed on the Attachment hereto for a total purchase price of one hundred twenty-five & 76/100 dollars (\$125.76) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 3. That the bid of the Northern Ohio Railway Museum, located at P.O. Box 458, Chippewa Lake, Ohio 44215-0458 for the purchase of one (1) skid (#925) of obsolete/scrap inventory as listed on the Attachment hereto for a total purchase price of fifty & 00/100 dollars (\$50.00) be and the same is hereby accepted as the highest responsive bid from a responsible bidder.

Section 4. That the General Manager of the Authority be and he is hereby authorized to enter into contracts with the parties as listed on the Attachment hereto which is incorporated herein and companies for the sale of said obsolete/scrap inventory as described on such terms as are in the interest of the Authority.



Section 6. That this resolution shall become effective immediately upon its adoption.


