

RESOLUTION NO. 2025-115

AUTHORIZING CONTRACT NO. 2025-156 WITH ORACLE AMERICA, INC. TO PROVIDE ORACLE EBS SOFTWARE LICENSES, MAINTENANCE & SUPPORT SERVICES FOR A PERIOD OF ONE YEAR IN AN AMOUNT NOT TO EXCEED \$756,632.95 (GENERAL FUND, MANAGEMENT INFORMATION SERVICES DEPARTMENT BUDGET)

WHEREAS, the Greater Cleveland Regional Transit Authority ("Authority") currently utilizes Oracle America, Inc. ("Oracle") licensed products for financial, procurement, and human resource management applications; and

WHEREAS, annual licenses, maintenance and support services are required to maintain these Oracle Enterprise Business Suite ("EBS") software applications; and

WHEREAS, these services are available from Oracle, the original licensor of these products, located at 500 Oracle Parkway, Redwood City, CA 94065; and

WHEREAS, R.C. 306.43(H)(3) provides that competitive procedures are not required when the expenditure is for a renewal or renegotiation of a lease or license for telecommunications or electronic data processing equipment, services, or systems, or for the upgrade of such equipment, services, or systems, or for the maintenance thereof as supplied by the original source or its successors or assigns; and

WHEREAS, Oracle has offered to provide said licenses, maintenance and support services for a negotiated amount not to exceed \$756,632.95 for a period of one year; and

WHEREAS, the General Manager, Chief Executive Officer deems the negotiated offer from Oracle to be in the best interest of the Authority, price and other factors considered and recommends acceptance thereof by the Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Greater Cleveland Regional Transit Authority, Cuyahoga County, Ohio:

Section 1. That the offer from Oracle to provide Oracle EBS software licenses, maintenance and support services, is hereby accepted.

Section 2. That the General Manager, Chief Executive Officer of the Authority be and is hereby authorized to enter into a contract with Oracle to provide Oracle EBS software licenses, maintenance and support services.

Section 3. This contract will be funded through the General Fund, Management Information Services Department budget, in an amount not to exceed \$756,632.95 for a period of one year.

Section 4. That said contract shall be binding upon and an obligation of the Authority contingent upon future funding, compliance by the contractor with the specifications and addenda, if any; bonding and insurance requirements and all applicable laws relating to contractual obligations of the Authority.

Section 5. That the Authority's Board of Trustees acknowledges that all DBE goal setting has been suspended, per USDOT Interim Final Rule issued October 3, 2025.

Section 6. That this resolution shall become effective immediately upon its adoption.
