#### Justification:

 Support Services is responsible for the management and oversight of the vending services contract for all internal district locations. Those locations are: Main Office Building, Hayden District, Triskett District, Rail District, Central Bus Maintenance Facility, Woodhill District, and Paratransit District.

Justification, continued:

- The vending machines are placed in the internal areas of the districts where only employees have access (except 1<sup>st</sup> floor of Main Office Bldg).
- There are a total of 35 machines throughout the district locations.



#### Scope of Services:

- The vending machines offer a quick, easily accessible solution for snacks, beverages, coffee, small meals, or healthy snack alternatives for GCRTA's 2,000+ employees throughout their busy work schedules.
- The revenue received by GCRTA from the vending machines is put into a pool of funds intended for employee activities coordinated by each district council group.



#### Scope of Services, continued:

- O Revenue Generating with commission guarantee
- O Vending machines will have credit card option
- O Vending services and supplies provided will include, but not be limited to:
  - Food (including healthy options)
  - Beverages
  - Condiments
  - Paper Products
  - Flatware
  - Napkins



- RFP issued December 10, 2018
- Proposals were solicited for a three year contract with two, one-year options
- Accessed on the GCRTA website by eight interested parties
- Two companies proposed
