Kansas City, MO (KCATA)

- December 2019: Resolution for Free Fares on system
 - Cost of going zero-fares: \$8 million per year (pre-COVID)
- Sales Tax: allocated from City of Kansas City, MO
 - Public Mass Transportation Fund
 - Additional 1/2 cent sales tax: permanent, enacted in 2015
- \$4 million dedicated by City
- \$4 million private funding



LA Metro

- Task Force launched September 2020: review zero-based fares
 - Passenger Fare Revenue: \$250-\$300 million/year
 - Findings/recommendations to Board in early 2021
- Sales Tax Revenue
 - Measure M:
 - 0.5% within Los Angeles County, enacted 2018 to June 30, 2039
 - Increases to 1% on July 1, 2039
 - Expected to generate \$120 billion over 40 years
