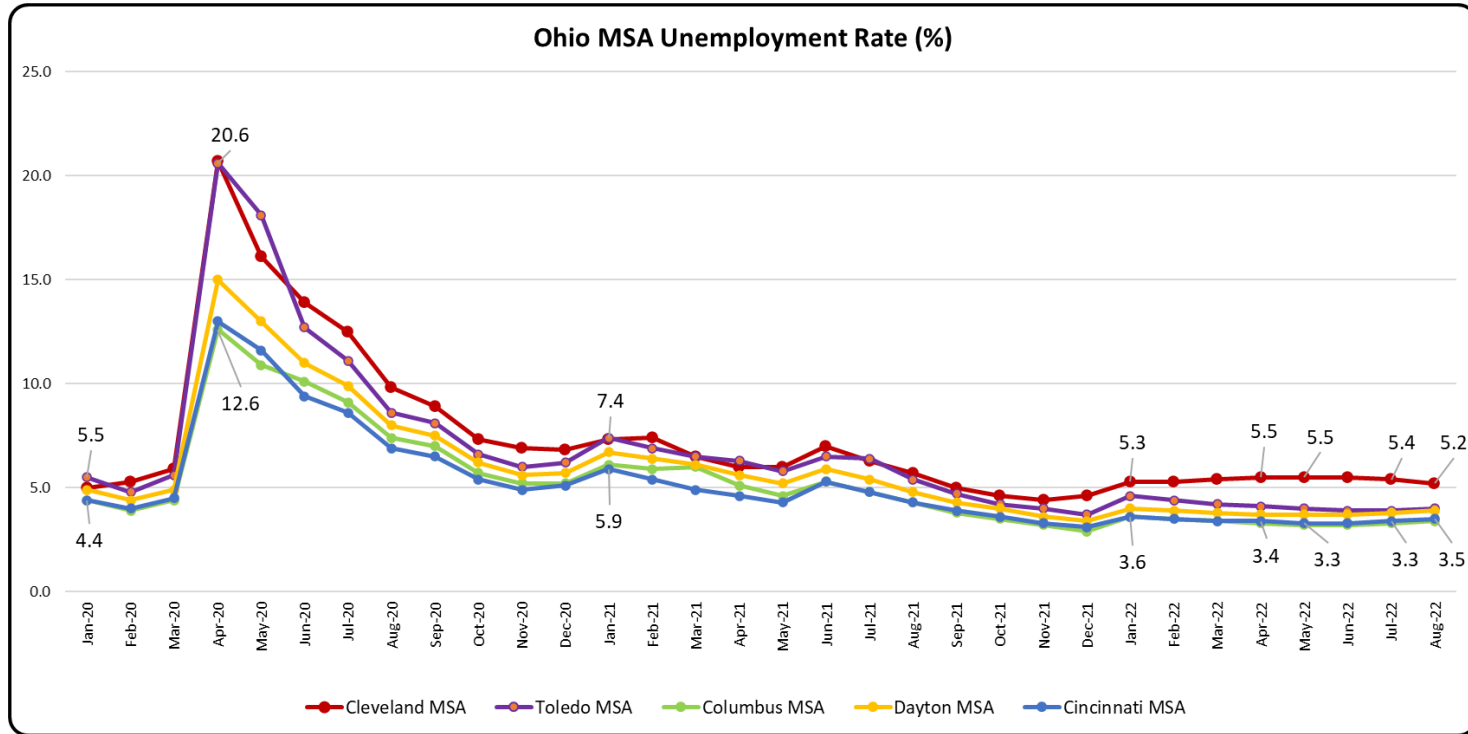

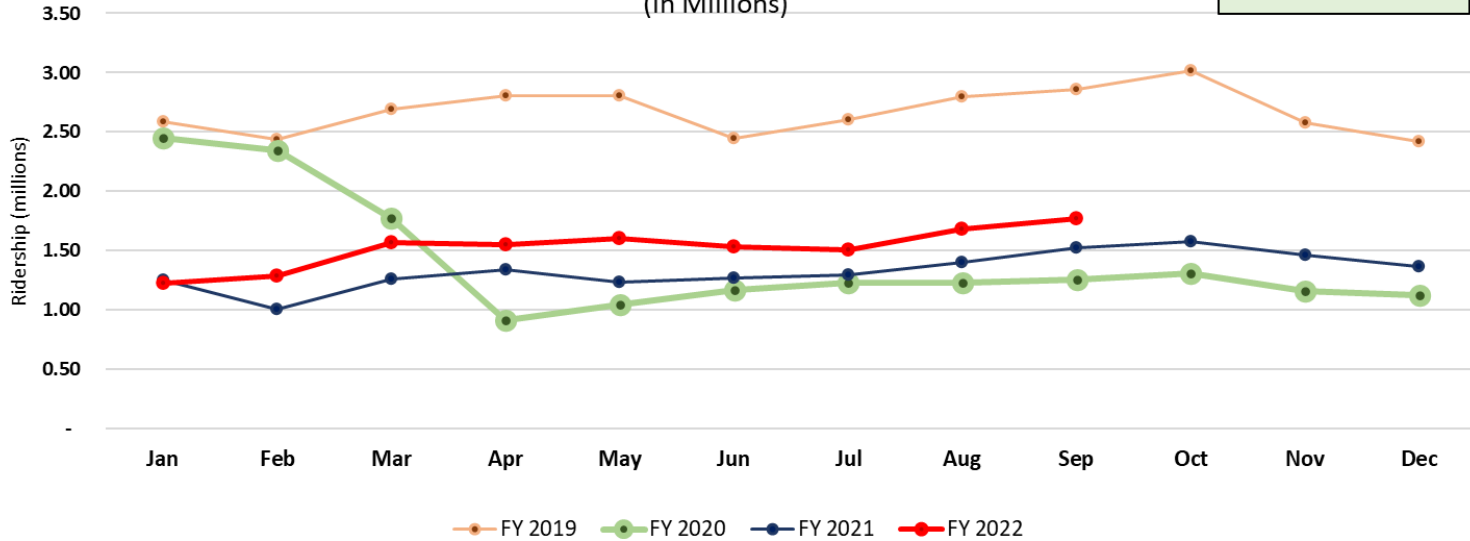

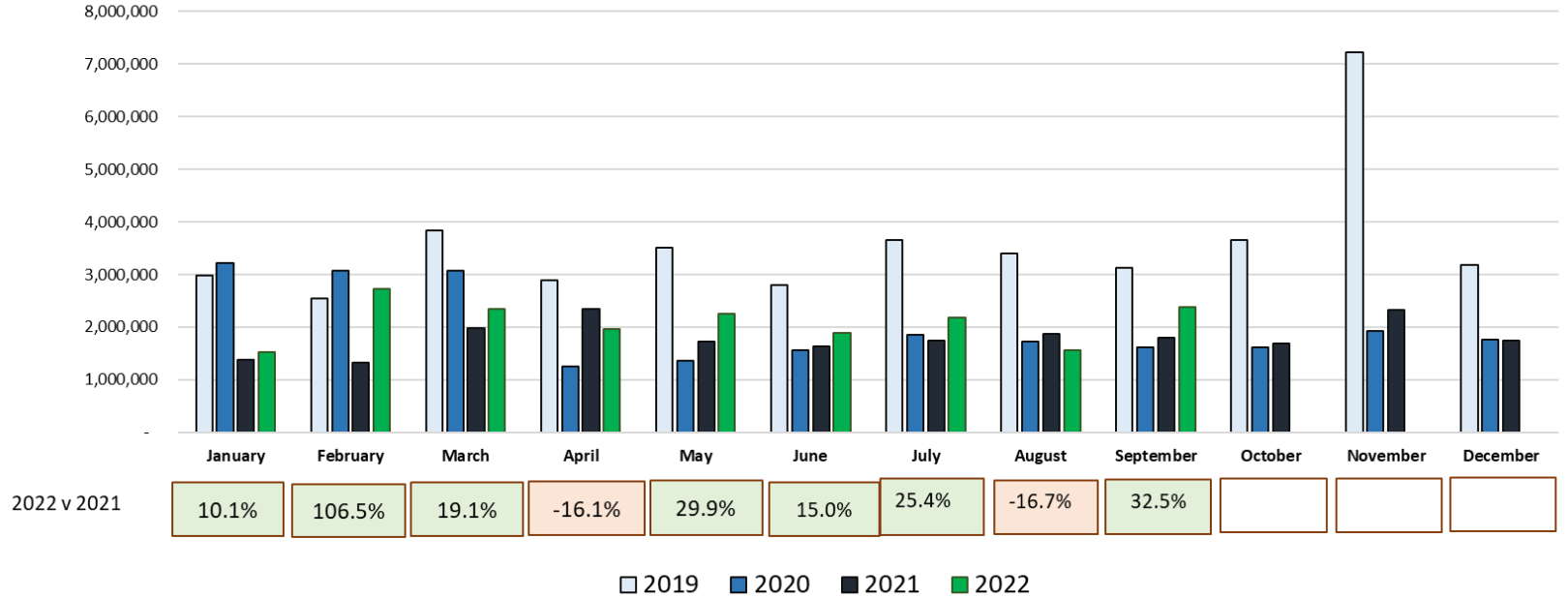

2019, 2020, 2021, and 2022

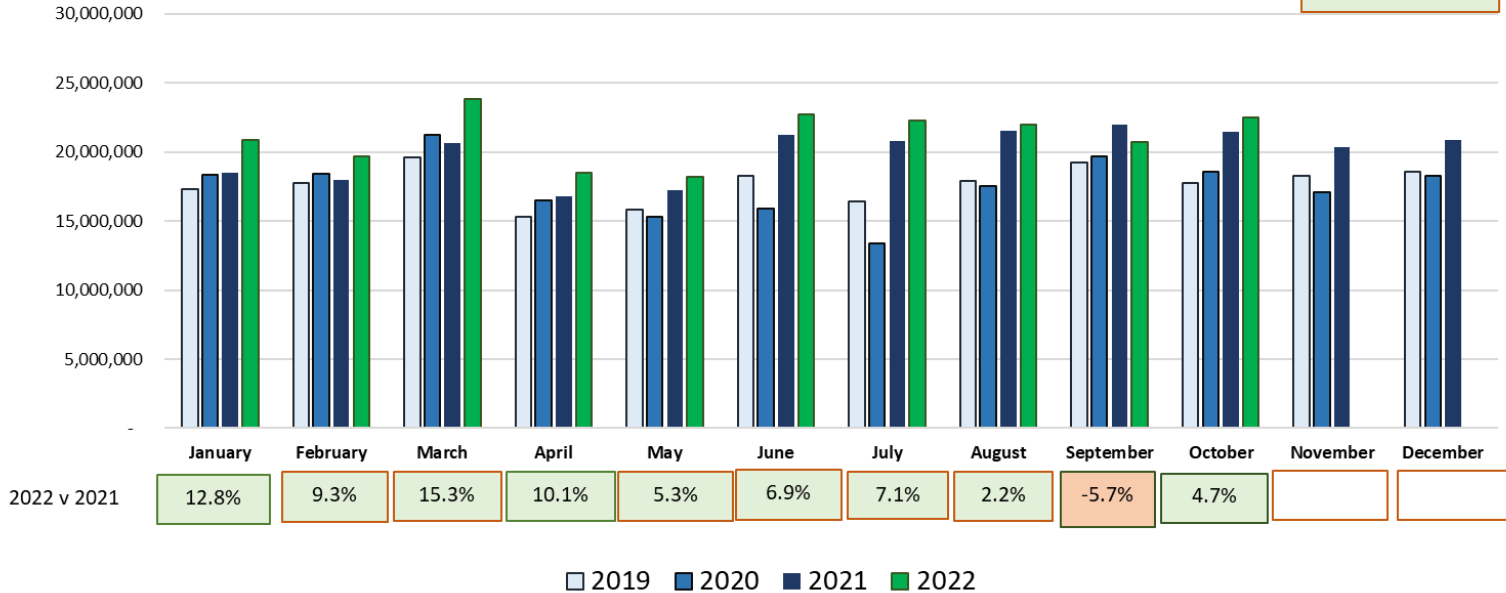
YTD Variance

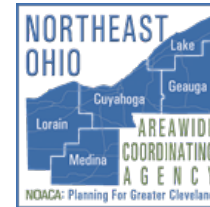
