## Civilian Oversight Committee (COC)

Committee of the Whole Board September 26, 2023













#### CIVILIAN OVERSIGHT COMMITTEE

#### **Phase 1 – Initiate** 10/1/21 – 7/29/22

- Present the Board with initial concept
- Gather necessary resources to support development of COC – *COMPLETED*

#### **Phase 2 – Plan** 6/1/22 – 8/30/22

- Develop necessary plans; seek BOT approval
- Review/finalize proposed Operating Procedures
- BOT to pass resolution for creation of COC COMPLETED

#### **Phase 3A – Execute** 8/31/22 – 11/28/22

BOT approves finalized Operating Procedures – **COMPLETED** 

#### **Phase 3B – Execute** 1/12/23 – 9/30/23

- Recruit and screen applications through 4/30/23 -**COMPLETED**
- Ad Hoc Selection Committee interviews candidates through 8/18/23 - COMPLETED
- BOT appoints seven members to COC WE ARE HERE

#### **Phase 4 – Control 9**/30/23 – 12/31/23

- COC members receive training
- COC Evaluation system established & implemented
- COC members continue training activities

#### Phase 5 – Close Project 1/01/24

COC becomes operational unit

#### **PURPOSE**

- To review/investigate public complaints filed against GCRTA Transit Police employees and make recommendations
- Recommendations must be consistent with GCRTA/TP rules, policies, procedures, collective bargaining agreement





#### **POLICE OVERSIGHT**

- Increases police accountability
- May assist in liability management/reduce the likelihood of costly litigation
- May identify areas of concern/offer options to improve policing
- Helps improve quality of Internal Affairs investigations
- Increase public understanding of police policies and procedures
- Fosters communication between community and police





### MEMBER QUALIFICATIONS

- Ability to remain objective/unbiased
- Reflect customer base
- At least 18 years of age
- Resident of Cuyahoga County
- No criminal history
- General understanding of GCRTA and TP services





#### COMMITTEE SELECTION

- Written Application
- Screening Committee (filters out unqualified candidates)
- Ad Hoc Selection Committee
  - Committee Chair Lauren R. Welch
  - Mayor Paul A. Koomar
  - Mayor David E. Weiss
- Board of Trustees makes final appointment from Ad Hoc Selection Committee's recommended candidates



#### **COMMITTEE COMPOSITION**

- Seven individuals from diverse communities within Cuyahoga County
- At least one retired police officer with Ohio Peace Officer Training Academy (OPOTA) training and investigative experience
- Selected by application to the COC by the Board of Trustees
- Terms for COC members shall be three years (staggered)
  - Three initial appointments for three years
  - Two initial appointments for two years
  - Two initial appointments for one year



## Ad Hoc Selection Committee's Recommended Candidates for Initial 3-Year Terms

- Auvil, Elise: Elise has served as an assistant public defender in both Philadelphia and Cleveland and served as an associate counsel for GCRTA from 1997 to 2003. Elise was also the former Chief of Staff for Mayor Justin Bibb. Elise is currently the Human Resources Consultant for EHA Solutions, Ltd. and has held that role for 8 years.
- Gordon, Jakolya: Jakolya has been a member of various community organizations including the Cuyahoga
  County Child Fatality Review Committee, Alliance for HOPE International, and the Alcohol, Drug, Addiction, &
  Mental Health Services Board. Jakolya currently works as a program specialist for the Cuyahoga County Public
  Safety & Justice Services and has held that role for 13 years.
- Taylor, George (OPOTA trained, retired police officer): George is a retired uniformed police officer who served the Toledo Police Department for more than 30 years. After retiring from service as a police officer, George continued to serve the community in various roles such as the Director of Public Safety and Justice Services for Cuyahoga County and the Chief Deputy of the Cuyahoga County Sheriff's Department.



## Ad Hoc Selection Committee's Recommended Candidates for Initial 2-Year Terms

- Clary, Timothy: Timothy has experience working as an attorney in a private firm handling litigation as well as serving as an assistant prosecuting attorney for Cuyahoga County. Presently, Timothy is working as an assistant public defender in the Cuyahoga County Public Defender's Office.
- Sims, Steven: Steven has engaged in public service throughout Cuyahoga County and Cleveland
  in various roles, including at GCRTA as the Director of the Office of Business Development.
  Steven currently serves as the President/CEO of the Greater Cleveland Community Credit Union,
  a financial institution focused on serving the unbanked and underserved communities of
  Cuyahoga County.



## Ad Hoc Selection Committee's Recommended Candidates for Initial 1-Year Term

- **Morris, David**: David has 20+ years of HR experience, with job duties and responsibilities including handling investigations of employee misconduct and citizen complaints. David presently works as the Human Resources Manager for the City of Bedford Heights.
- Wharton, Rebecca: Rebecca presently works as the HR manager for Malachite Innovations, L.L.C. and has responsibility and oversight of over 60 company clients. Rebecca has a history working in a multitude of HR-related positions including the management of all aspects of HR duties and responsibilities. Rebecca also worked as a constituent liaison for the State of Ohio's Department of Public Safety.



### Recommendation

On behalf of the Ad Hoc Selection Committee, Staff requests that the Committee of the Whole recommend to the Board of Trustees the appointment of the seven recommended candidates as members of the Civilian Oversight Committee.







2020: 12.13






