President Lucas added that the new fleet will have built in ice cutters. He thanked all the funding sources. Mayor Koomar asked for an update on functionality of the new fleet. Ms. Terry said the new fleet will have one car for light and heavy rail. It will open opportunities for new train lines with enhanced trip patterns. Mayor Weiss asked about the infrastructure changes at Tower City. Dr. Caver said there may be some platform extensions. They are working through those changes and which station will be used for through trains. No new track will be needed.

Contract Update

- Base contract authorized by Resolution No. 2020-62 in an amount not to exceed \$398,480.00
- Notice to Proceed effective September 25, 2020
- Change order limit of \$100,000.00
- Change Order No. 1 was utilized for Manual Block Operation Hazard Analysis in an amount of \$79,542.00
- \$20,458.00 remains in General Manager Change Order Authority
- Proposed Change Order of \$39,002.00 will cover additional cost for meetings and travel and also extend the contract for 14 months

Staff requests that the Committee of the Whole recommend approval of the proposed change order to K&J Safety and Security Consulting Services, Inc. in a negotiated amount not to exceed \$39,002.00, resulting in a new total contract amount not to exceed \$517,024.00. This change order will also reinstate the General Manager's change authority to \$100,000.00.

It was moved by Ms. Welch, seconded by Mayor Koomar and approved to move this to the full Board.
