Summary of Proposed Award Furnishing of Vehicle Towing and Flat Tire Replacement Services For a Period of Five Years

Presented to: Organizational, Services & Performance Monitoring Committee March 4, 2025

- The Authority requires approximately 600 vehicle tows and/or onsite flat tire repairs per year.
- Towing services address a need for mechanical failures, collision recovery and safety measures.
- On-site tire repairs ensure minimal service interruption for our riders.

J Ross Express Inc. is the current provider of these services.

In April, 2020, the Board of Trustees authorized the current contract to J Ross Express Inc. in an amount not to exceed \$338,280.00 for the base three-year period and in amounts not to exceed \$112,760.00 for each option year for a five-year total not to exceed \$563,800.00.

- In partnering with the Transit Police, this contract also provides a public safety service allowing for the removal and recovery of vandalized vehicles from our properties.
- This contract provides towing and flat tire services for all Authority-owned vehicles.

- The Invitation for Bid was issued on January 5, 2025.
- Nine interested parties downloaded the solicitation.
- Two responsive bids were received on February 7, 2025.
- A summary of those bids is as follows:

- J Ross Express, a local Ohio company, was determined to be the lowest responsive and responsible bidder.
- A 0% DBE participation goal was assigned to this procurement by the Office of Business Development.

Warrensville Van Aken Station Reconstruction **Operational Planning & Infrastructure** Committee March 4, 2025

- The station serves GCRTA Light Rail system at the end of the Blue Line and GCRTA busway transfer point for 14,14A, 41 and 41A bus routes.
- GCRTA partnered with the City of Shaker Heights and the Van Aken District owners, RMS, to rehabilitate and enhance the station site.
- Purpose of Project:
  - Create strong connection to GCRTA train station, busway, commercial district, and neighborhoods.
  - Create architectural space to uplift and inspire community.
  - Provide quality service.
  - Update ADA accessibility and security.

#### Phase 1: Mixed Use Development

- \$100 million, completed 2019.
- 100,000 SF of new commercial space
- 65,000 SF of new office space

- Multi-million, substantial completion 2024
- 226 new apartments

- Construction completion, anticipated 2025.






### Van Aken District - Public Art - Community

- Artwork serves as a shade structures for the new plaza.







#### **Procurement Overview**

- Invitation For Bid (IFB) issued December 13, 2024.
- Accessed on the GCRTA website by forty (40) interested parties.
- Five (5) firms submitted a bid.
- Three (3) bids were deemed responsive.

Lowest responsive and responsible vendor:

Mike Coates Construction Co., Inc. of Niles, Ohio

A 17% DBE participation goal was assigned to this procurement by the Office of Business Development and will be achieved by utilizing:

• Irizar Electric LLC

Firm Experience:

- Mike Coates Construction Co., Inc. has successfully completed projects for City of Westlake, Erie County, Western Reserve Transit Authority, City of Warren, and City of Canton, among others.
- Mike Coates Construction Co., Inc. has current projects with Youngstown Air Reserve Base, French Creek Twp., City of Canton, and Ursuline Motherhouse Assisted Living Facility, among others.

Recommendation:

Staff requests that the Operational Planning & Infrastructure Committee recommend award to Mike Coates Construction Co., Inc. for the Warrensville Van Aken Station Reconstruction. The contract is in an amount not to exceed \$6,702,676.00.

# Permanent Easement with Port of Cleveland for Connector Track

- Essential to the railcar replacement program
- Covers the construction, operation, use and maintenance of the connector track and related rail infrastructure
- Location at Port of Cleveland in existing freight rail corridor
- Site is conveniently located to GCRTA tracks

# Permanent Easement with Port of Cleveland Connector Track

- New railcars arrive by freight rail to the Port of Cleveland in Mid-2026
- Siemens transfers railcars from freight line to the Waterfront Line and moves via locomotive to GCRTA's Brookpark Yard
- New railcars are to be commissioned at the Brookpark site off the Red Line near Airport

# Permanent Easement for Port of Cleveland Connector Track-Terms

- Non-exclusive GCRTA has priority of use
- 40 Feet Wide / 0.3932 acre / 17,128 square feet
- No cost to GCRTA for easement rights
- Construction cost of connector \$900,000

# Recommendations

Staff request the Audit, Safety Compliance and Real Estate Committee recommend approval of a Permanent Easement Agreement with the Cleveland-Cuyahoga County Port Authority for the construction, use, operation and maintenance of a connector track, delivery switch and related facilities at the Port of Cleveland for the delivery of replacement railcars
