The meeting was called to order at 5:06 p.m. There were four (4) Civilian Oversight Committee ("Committee") members present.

It was advised that notice of this meeting had been posted more than twenty-four (24) hours in advance of the meeting, that the usual notification had been given to the news media and other interested persons, and that all requirements of the Ohio Revised Code and Rules and Bylaws of the Board of Trustees regarding notice of meeting had been complied with.

Approval of September 30, 2025, Committee Meeting Minutes

The Committee decided that, due to several of their members missing, they would postpone the approval of the September meeting minutes. It was moved by Ms. Wharton and seconded by Ms. Gordon for approval. All were in favor, and none opposed. The approval of September 20, 2025, meeting minutes will be postponed until the January 2026 meeting.

Introduction of Mayor Gallo as the new Board of Trustees Liaison for the Committee

Mayor Gallo introduced herself as the Mayor of Parma Heights for the last four (4) years and was just re-elected to a second term. Prior to being mayor, she was the HR Director for the City of North Olmsted and was a City of Parma Heights Council member for twelve (12) years. She was elected earlier this year to serve on the GCRTA Board of Trustees. Mayor Gallo expressed her appreciation for the work that GCRTA does and is happy to be the Liaison for this Committee. She also added that she attended Baldwin Wallace University many years ago and has a degree in criminal justice.

Dr. Caver added, on behalf of the management team, he would like to thank Mayor Gallo for joining the Committee, and looks forward to her leadership on this Committee. Dr. Caver stated that this is an amazing opportunity to have a mayor as a part of the Committee because, as mayor, she is the chief safety leader for her community and has a very strong understanding of the work and expectations of professional police departments. Additionally, he is excited to see Mayor Gallo's commitment to activism and would like to thank her for taking this opportunity.

Ms. Gordon asked that each of the Committee members briefly introduce themselves to Mayor Gallo and say why they are a part of the Committee.

Ms. Auvil stated that she has a long tenure in government. She has served as a Director of HR. Many years ago, she served as an attorney for the GCRTA and did a lot of work with Transit Police at that time. Ms. Auvil continued by stating that she thinks Transit Police is a great unit and that the organization is fantastic. Ms. Auvil ended by stating that she likes giving back to the community and that is why she is on the Committee.

Ms. Wharton stated that she started her professional career with the State Government at the Ohio Attorney General's Office and then went to the Department of Public Safety, so she has a background with law enforcement. Ms. Wharton stated that police oversight has always been of interest to her and when an opportunity to be on the Committee became available, she wanted to be involved. Ms. Wharton added that she is a resident of Downtown Cleveland, making it a perfect fit for her.

Mr. Taylor stated that he has forty years of law enforcement experience, most of it being in Northwest Ohio, some in Columbus. His last position was here in Cuyahoga County as the Deputy Chief of the Sheriff's Department. Mr. Taylor added that he is on the Committee because he believes that oversight is needed, but you also need a voice from someone who has been there and done that, and that he thinks he brings that voice to the Committee.

Ms. Gordon stated that she has been a part of public service for twenty-five (25) plus years and is currently employed with Cuyahoga County. Ms. Gordon stated that being on the Committee is personal for her as her mother is a proud retiree of GCRTA, making her involvement a legacy. Ms. Gordon added that even though she is not an operator, she is operating in the capacity of oversight. Like her fellow Committee members, she is excited to be here and contribute to make sure rules and policies are being followed so citizens are being impacted properly.

Executive Session Requested

Ms. Bailey informed the Committee that there was a request to remove the executive session from the agenda. There were no objections from the Committee members.

New Business

Reports and Announcements

Ms. Bailey informed the Committee that at the November Board of Trustees Meeting, Jonathan England and Michael Blake were reappointed to the Committee. Both were unable to be present at the Board Meeting so they will be re-sworn in at a later date.

5:15 p.m. – It was moved by Ms. Wharton and seconded by Ms. Auvil that the meeting be adjourned. There were four (4) ayes, and none opposed. The meeting was adjourned.

- **Sustained for Violation Not Based on the Original Complaint-** There is sufficient evidence to establish that an act of misconduct occurred that was not part of the violations alleged in the Complaint.
- **Unfounded-** The alleged acts did not occur, did not involve Department personnel, or are frivolous.
- **Exonerated-** The alleged acts occurred, but were justified, lawful, and/or proper.
- **Not-sustained-** The facts and circumstances fail to establish if the conduct occurred.
- **Administratively Dismissed-** The complaint is not GCRTA related, does not involve a Transit Police employee, or is related to a service delay that is determined to be unavoidable.

On Wednesday, July 23, 2025, at approximately 7:43 am, I was exiting the last westbound train car toward the airport at the Triskett Train Station. As I stepped off, Det Kemmett (#85) rushed toward the train as if responding to an emergency. He and his partner, Det. Adkins (#56), split up; Kemmett entered the car I had just exited.

Det. Kemmett nearly bumped into me, without saying "excuse me" or showing any manners. I calmly asked him, "You can't say excuse me? You don't have manners?". He ignored me and the train door closed. I then tapped on the window and said, "Next time, why don't you try using some [REDACTED] manners?" Following this, Det. Kemmett radioed in and falsely reported that I was being disorderly, which was untrue. This was the beginning of the harassment.

Det. Kemmett aggressively forced me to give my identification, which I did not have immediately with me. He also coerced me into giving my date of birth and Social Security number. Despite not committing any crime, he threatened to arrest me on an outstanding warrant I was already aware of and actively addressing through the courts. He also threatened to use excessive force if I did not comply, repeatedly taunting me by saying that the next time I "bumped" into him he would take me to the ground and arrest me. I never bumped into him; it was he who almost collided with me.

I asked multiple times if I was being detained. He said no but simultaneously impeded my movement, preventing me from leaving the area without justification.

Det. Kemmett also asked inappropriate questions about my pre-release status and GPS monitor, information unrelated to any ongoing matter and which I am not required to discuss without an attorney present.

Det. Adkins (#56), his partner, witnessed all of this and did nothing to stop the illegal harassment and intimidation. He eventually gave me his badge number after I repeatedly asked, and only did so after I called the number I found online, +1 (216) 566-5163, and demanded to speak to a lieutenant because I felt harassed, abused and betrayed by people who are supposed to protect me. After that call, I took pictures of the officers involved.

Ofc. Irizarry (#15), who arrived as a backup, refused to provide his badge number or identify himself properly. He also tried to intimidate me by telling me I would never find contact information for supervisors, which I later found online.

Ofc. Brown-Kirby (#112), a Black female officer, observed the incident and listened as I explained what was happening. However, she refused to provide her badge number or identify herself when asked and attempted to avoid involvement by walking away. Her behavior made me feel betrayed as Black man being harassed and intimidated.

Officer Campbell (#80) was the dispatch officer who informed me via phone that the lieutenant was en route to Tower City Station.

Lt. Medlong (#924) was not present during the incident at Triskett Station, but met me later at Tower City to provide paperwork related to the incident.

Throughout the entire encounter, my girlfriend Latonya [REDACTED] and my god sister Mari [REDACTED] were on speakerphone in my pocket, listening to everything that was happening. The officers did not know I was on the phone with them, and both women were disgusted at the threats, harassment and intimidation I faced.

As a 37-year-old Black man with PTSD, panic attacks and anxiety, this encounter triggered significant emotional distress. I fear for my safety and wellbeing on RTA premises due to the hostile and aggressive behavior of Det. Kemmett and the lack of intervention by his partner and other officers.

This situation was entirely avoidable. I did nothing wrong. I simply held an officer accountable for his lack of manners and was met with intimidation, harassment and threats of violence from someone who abuses their badge and power.

I demand a thorough investigation into the misconduct of these officers and appropriately disciplinary actions to prevent this from happening to others.


