## Memorandum of Understanding Between

## Transfer Of Seniority From One Bargaining Unit To The Other Bargaining Unit

The Greater Cleveland Regional Transit Authority, the Fraternal Order of Police and the Amalgamated Transit Union, having met and conferred, agree to the conditions of employment outlined herein. Except as outlined in this agreement, no other terms and conditions shall be provided for in the Collective Bargaining Agreement between the GCRTA and the ATU effective August 1, 2006 through July 31, 2009 or the Collective Bargaining Agreement between the GCRTA and FOP effective March 1, 2004 through February 28, 2007.

- The Parties agree that effective the date of this agreement forward that Mr. Don Nelson will receive credit for his service as a FOP represented transit police dispatcher. This seniority credit will be used only for the purpose of determining where he is in the wage progression.
- 2. The Parties agree that based on this seniority adjustment for Mr. Nelson, the Authority will adjust his pay step to the third step of the wage progression of his current classification as a Grade 550 Signal Maintenance Technician. Mr. Nelson will not receive any retroactive wage adjustment based on this memorandum of understanding. The Authority will adjust Mr. Nelson's wage step effective with the payroll period following the signing of this agreement. Mr. Nelson will be eligible to move to the next wage step as a Grade 550 Signal Maintenance Technician on September 10, 2007.
- 3. The Parties acknowledge that the ATU offers this seniority credit to Mr. Don Nelson with the understanding that the FOP will negotiate similar language with the GCRTA during contract negotiations in 2007.
- 4. The Parties acknowledge that if the FOP and the GCRTA do not negotiate similar language, the ATU will not accept seniority time earned by any other employee while working in a position represented by the FOP.

The GCRTA, the ATU & the FOP acknowledge that they have had ample opportunity to confer and bargain over all negotiable matters affecting the conditions of employment regarding the above referenced issue. This agreement represents a complete and final understanding between the GCRTA, the ATU and the FOP on all bargaining issues regarding the transfer of seniority time between bargaining units for the purpose of determining an employee's place in the wage progression scale.
