49 CFR, Part 670 Background

The Final Rule provides the framework for FTA to monitor, oversee and enforce transit safety, based on the methods and principles of Safety Management Systems (SMS)





49 CFR, Part 670 Major Provisions

- Monitor More data collection and SMS
- Oversee More involved State Safety Oversight Agency (SSOA)
- Enforce Withhold funds for non-compliant SSOAs and Agency Safety Programs





SMS – 4 Pillars

- Safety Management Policy
- Safety Risk Management
- Safety Assurance
- Safety Promotion





SMS – Answer 5 Questions re: Safety

- O What are the serious concerns in an area?
- o How do we know this?
- O What are we doing about it?
- o Is what we are doing working?
- O How do we know what we are doing is working?





Agency Safety Plan (49 CFR Part 673)

- Board of Directors approve the plan and any updates
- Designate an Accountable Executive ultimately responsible for Safety
- Designate a "Chief Safety Officer" who reports directly to the GM





State Safety Oversight (49 CFR Part 674)

- Strengthens SSOA authority to investigate
- Expanded criteria for what is reported to SSOA
- FTA can impose penalties on States with non-compliant safety oversight programs

Financial and Legal Independence	None Required	SSOA is financially and legally independent from any entity it oversees
Operational Independence	None Required	Does not provide public transportation services in an area with fixed Rail Fixed Guideway (RFG)
Administrative Independence	Entity could not provide services to both the oversight agency and the transit agency it oversees	Does not employ any individual who is responsible for administration of RFG
Oversight Agency Authority	Varied from state to state	Authority to review, approve, oversee, and enforce the implementation by the RFG agency of the Agency Safety Plan
Investigative and Enforcement Authority	Varied from state to state	Has investigative and enforcement authority with respect to the safety of RFG public transportation systems of the eligible State.
Triennial Auditing	On-site reviews at least every 3 years	Wording change for "review" to "audit"
Annual Reporting	Annual certification of compliance submitted to FTA	Provides a status report on the safety of RFG system to the FTA, Gov. of State, and Board of Directors

Concept

The Enhanced Transit Safety Retrofit Package (E-TRP) is 2-year project awarded by the FTA to Battelle and GCRTA

The project is being undertaken to **SAVE LIVES**

 Secondary goal is to Create a "Connected Vehicle" environment





Logistics of E-TRP

- 5-10 intersections (approx.)
- o 91 Buses
- Operator Focus Groups (Saving lives only happens with detailed Operator feedback)





Two Ways to Save Lives

Project 1 involves...

- V2I technology to prevent collisions with pedestrians that are in/near intersections and in crosswalks
- V2V technology to warn buses being "cut off"
- Installation of back-up cameras






Two Ways to Save Lives (Cont'd)

Project 2 involves...

- Alerting customers at Bus Stops/Transit Hubs
 of approaching and exiting buses
- This portion is known as "Transit Bus Stop Pedestrian Warning"











Latest News

- 1st Pilot Bus outfitted by Battelle week of
 9/26/16
- Wi-fi to be installed in Triskett and Hayden for automatic data upload
- City of Cleveland Traffic Engineering meeting with Battelle on 10/12/16.





Early 2017

- First 6 pilot buses on road for active testing
- Use Harvard for testing of VPoL technology
