
Enhanced Transit Vehicle Retrofit Package (E-TRP)

- Designed to:
 - Save lives
 - Warn Operators of Potential Pedestrian Collisions
 - Prevent Potential Vehicle-to-Vehicle Collisions
- Six-month Pilot (February 2 – August 2)
- Three Intersections, 24 Coaches



Connected Roadside and Vehicle(s)

Roadside cameras and [sensors] communicate (V2I) pedestrian presence on curb or in crosswalk to Roadside Unit (RSU)

Buses [and cars] communicate with RSU (V2I) to obtain signal phase (Red, Green, Yellow), permitted lane movements, and pedestrian presence




On Board Unit (OBU) installed in Buses [and cars]

Buses [and cars] communicate (V2V), share location and heading [and details such as gear/brake status and weather data like wiper status]







Rail System Safety Program Plan (RSSPP)

- Will act as interim Agency Safety Plan
- Primary goal is to plan, design, construct, test, and operate a rail system that attains an optimum level of safety
- Required to be approved by Board annually
- 21 sections audited over 3 years
- Triennial Audit every 3 years


